There are a couple of corrections that I suggest you make to this letter. First of all you state "there are people in our assembly who believe (Denise's) viscous attacks on others to be part of a calculated, intentional conspiracy to capture our entire state starting with Clark County – that she is knowingly working with FBI or other LEOs to create chaos within our state assembly, perhaps to have some criminal record cleared or for other personal gain." You seem to imply that these statements were made by the Vetting Committee. There are only two conversations where this idea was floated that I'm aware of. One private conversation I had with you where **you** raised the suggestion that she could be a paid infiltrator and I disagreed. As I explained to you, I do not think she's a paid infiltrator I think she is just a very dishonest, manipulative, and petty woman and that's what I expressed to you during what I thought at the time was a private conversation. The second was during the confidential meeting **you** asked to have with the vetting committee and **you** raised that concern also. No one took the bait but it's apparent now that that was an attempt to bait us into saying that. None of us agreed with you but here we are defending against another accusation. Henceforth to avoid this type of "misunderstanding" all communication will be recorded.

Secondly, I requested a week to work on putting the vetting report together. As I recall you were the one who suggested the report be completed sooner and suggested Wednesday. This was exceptionally bad timing for me. I had The Jural assembly meeting that night and many emails to answer regarding the Jural Assembly meeting in addition to the fact that I have been working at this almost full-time and I'm falling behind in a lot of my other obligations. However, myself and the rest of the committee managed to get feedback in on time. Because your email was sent during a time when you knew I was dealing with the Jural Assembly meeting, it got overlooked and I apologized to you for that even given the circumstances. You failed to meet the deadline and I'm to blame for that so you write an email in anger which you should know will be made public and used to fuel additional hate towards innocent people. Really disappointing.

Regarding the situation with Denise, despite the constant vicious and dishonest attacks I have always proceeded with honesty and fairness in my responses to her. You will not be able to come up with a single situation where I was the one initiating conflict. In every single instance I've been defending against the constant attacks and have remained kind and professional, even giving opportunities for course correction every step of the way. The public letter I sent to her was **in response to direct attacks and attempts to bully me into stepping down** and after many witnesses informed me that Denise called multiple people with the purpose of attacking my character and spreading lies. Again, I have evidence and witnesses to support this statement. I would think anyone could look at the documentation and speak to the witnesses and figure this out.

Another false statement is that the State has been "stagnant" over the past 3 years. This statement is being made by Denise and parroted by people who have sat with their thumbs up their rear ends doing nothing while the rest of us have been busting our asses working almost full-time making significant progress toward building our 4 pillars. This statement is an insult to Craig and Mark in addition to a handful of others who have put loads of time and effort into building our Assembly. The Assembly met with Lisa Schaefer in June of last year and since then Brian and Peter, in addition to a few others, have been working on taking all the pillar documents Lisa gave us and customizing them for the Nevada assembly. On almost every call since June and in multiple emails, they have given updates and asked for feedback and help. They have gotten little to nothing in return aside from input from Mark and I. If you're interested in speeding up progress you should step up to the plate and help.

The suggestion that Denise has made an "immense contribution" to our assembly is ridiculous. Her big "accomplishment" is that she sent an extremely poorly written un-reviewed and unapproved notice to the defacto about fluoride that is based on an idiotic presumption. That notice being sent is an embarrassment to the entire assembly and makes us look like a bunch of clowns. She's put out some marketing materials including one that has a QR code that doesn't even work. Per her own statements made during a Clark County meeting, she went to a gun show presenting herself as the "Clark County Assembly" and got into a verbal altercation with a defacto police officer. She's also taking work that was already done by others and putting her name on it. The only thing she's done for building the 4 pillars is hamper and slow the people who are actually doing the work with her constant, immature attacks based on lies. She appeals to the masses because she has spread the rumor that other states are getting funding and Nevada is not because of something Mark and I did or didn't do in addition to many other lies.

Rockie has aided and abetted her even though he himself has admitted she lied and misrepresented claims she made on her first ever assembly call and I have an email to prove that. Our generous and kind attempt to offer him an opportunity to course correct and help us bring the assembly together was not only refused but rejected with threats. He is completely unqualified to run a County Assembly. In addition to his lack of written communication skills, he throws out defacto terms like "slander" without the simplest basic understanding of the definition of that word. He accused the vetting committee of **defamation and slander** because I sent him a **private** communication regarding the vetting results. The statement he took issue with did not definitively accuse him of anything. In fact, it says right in the letter the court documents found could not be verified and wasn't the basis of our decision. **He** made the document **public so he should report himself for committing slander against himself!** The next level ignorance he displayed here is unbelievable.

You also claim in your letter that the inflammatory rhetoric against Doug on the "Clark County" website has been removed. This is also false. Doug is writing his own response to you which will include proof of inflammatory rhetoric and false information still on the website as of Monday March 3rd.

The "dynamic duo" of Rockie and Denise has, and will continue to, ruin the previously good name of our Assembly and will probably get a lot of their followers into trouble. If that's what you want for the Assembly and the masses, you're free to make

that choice. Meanwhile, myself and others will continue busting our asses daily and will continue to make real progress towards actually building our four pillars
