I received an email sent out November 21, 2025 by the instigator of division, Rockie Roper, on Clark County via his fraudulent email address coordinator@thenevadaassemblygov.land. Once again, he is proffering unsubstantiated lies and division in an effort to divide and undermine the integrity of The Nevada Assembly. This time, he accuses the Nevada Militia Assembly of "promoting getting firearms" for Militia Assembly members. Well, of course, we encourage all our members to "get firearms" for self-defense, as is their right. But he goes on to conflate that

with “terrorist” activity, what? You can kind of relate them to FEMA, but the good guys are ready to help when needed. Do not fall into this de-facto trap.”

Firstly, nothing remotely akin to this was ever put forward by the Nevada Militia Assembly. I am not sure where he got the “given information,” but it was completely fabricated. Secondly, for anyone to purport to represent any of our ASNs and make such a statement is completely reckless and irresponsible and places our entire Assembly at risk of unwarranted and unwanted de facto scrutiny.

Our Nevada State Coordinator has asked me to investigate this matter, and I intend to do so. In the meantime, Rockie Roper has once again proved himself to be a reactionary willing to create any inflammatory conditions possible to undermine our collective work to stand the Nevada State of the Union, as long as he can pretend to be relevant in any of it.
